- In 2021, the global LawTech market generated revenues of US\$27.6 billion. It is anticipated to reach US\$35.6 billion in 2027.[#]



Conditions of Application: By agreeing to the eBRAM Arbitration Rules, parties may use the platform to resolve the dispute for any amount by arbitration. Interim Measures Arrangements

As **one of the six recognised institutions** under the Hong Kong, China-PRC Interim Measures Arrangement, parties to arbitral proceedings administered by eBRAM would be able to apply to the PRC courts for interim measures.

eBRAM Model Clauses

eBRAM Online Arbitration Model Clause

Any dispute, controversy or claim arising out of or relating to this contract, or the breach, termination or invalidity thereof, shall be settled by arbitration in accordance with the eBRAM Arbitration Rules.



eBRAM Online Mediation Model Clause

Any dispute or difference arising out of or relating to this contract shall be referred to the eBRAM International Online Dispute Resolution Centre Limited and resolved in accordance with its current Mediation Rules.

Parties may consider adding:

- The number of arbitrators
- The place of arbitration
- The applicable law of the arbitration agreement and of the procedure
- The language used in the arbitration
